Advancing Practice

is a one-year PAID Fellowship that builds on nurse practitioner (NP) and nurse midwife (CNM) academic programs to prepare recently-graduated NPs and CNMs to become expert clinicians as well as nursing leaders.

Erie Family Health Centers (Erie), a federally qualified health center in Chicago with 87,000+ patients, and the University of Illinois at Chicago College of Nursing (UIC Nursing) have partnered to create this program with the goal of expanding access to affordable, quality healthcare in underserved communities.

Health Equity: A Cornerstone of the Advancing Practice Mission

Nurses have historically stood up to oppression, racism, and classism by treating the most vulnerable populations in need of care. Achieving health equity and respecting human dignity are at the core of the nursing profession. *Advancing Practice* will prepare you to be the next generation of APRN advocates and leaders. At Erie Family Health Centers, you will be mentored in an organization that values diversity, equity, and inclusion.

FAQs

Is this a paid fellowship?

Yes. Fellow will be paid 70% of market rate for APRNs in Chicago. If a fellow decides to stay at Erie after the fellowship, we will pay them as if they have 2 years' experience to help make up the difference.

Do we get benefits and time off?

Yes. Fellows will be treated as Erie employees and will receive full benefits including medical insurance, a 401k, and 4 weeks of PTO.

Are the Spanish Language courses required?

Yes, every fellow, regardless of Spanish knowledge, will be required to attend Medical Spanish courses either in person at a local institution, or online. The majority of Erie Family Health Centers' patient population is Spanish speaking. These classes will be paid for by the Fellowship and will take place during orientation and throughout the year.

How does the clinic schedule look?*

Will the schedule vary?*

For NPs, you will have four days of clinic a week. For CNMs, you will have 2-3 days of clinic, plus one 24 hour call, with the following day off. For all fellows, one day will be reserved for administrative work and didactics. Everyone is required to work an evening once a week (until 7:30) and work one Saturday per month. The week before or after that Saturday, you will have a day off.

At what sites will we see patients?*

Erie has 13 sites, 11 of which are located in the Chicago area. There is one location in Waukegan and one location in Evanston. All locations will be utilized during the Fellowship year and will be determined before the start of the program. Continuity clinics will be held at the same site for each fellow in order to have consistent patients. Mentored clinics and specialty clinics will change throughout the year. You must have reliable transportation and be willing to travel to Evanston and Waukegan.

Are we an accredited program?

We are currently in the accreditation process with the National Nurse Practitioner Residency and Fellowship Training Consortium. We hope to be an accredited program by the start of the 2023 cohort.

How will the specialty rotations work?*

Every month you will work a different specialty within primary care. A few specialties we provide are Infectious Disease, Psychiatry, Behavioral Health, Procedure Clinic and Women's Healthcare.

How many fellows are you accepting?

The number of Fellows we hire will be dependent on the organizations needs and will not be determined until spring 2023.

How will precepting work?

Our preceptors go through an extensive training and orientation process. Just as the Fellows are evaluated on a trimester basis, the preceptors are also evaluated to ensure we are meeting the fellows needs. Every fellow will be assigned core preceptors that are consistent throughout the year, however fellows will work with multiple preceptors throughout the year.

Are there specific requirements after the fellowship year?

You do not have to stay with Erie after the fellowship year. However, we encourage you to apply for available positions at the end of the fellowship year. If you do not want to stay with Erie, we will support and help you find a new place of employment.

Will CNMs be provided a full scope of practice?

Yes, this is a full scope CNM position. The position will include one 24hr inpatient hospital call per week and about 20 hours of outpatient care. In the outpatient setting, we average 60% OB and 40% GYN (annuals, family planning and method inserts, problem GYN).

Is there relocation reimbursement?

No, but we can offer assistance in choosing a neighborhood to reside in and commuting options.

By when do you have to graduate to be eligible to apply?

Applicants must graduate from their academic program between March 2022 and May 2023. You must schedule your board exams no later than June 30, 2023.

If accepted into the Fellowship, am I able to still apply for a HRSA Loan Repayment Program?

If you are able to apply for the HRSA National Health Service Corp or Nurse Loan repayment program, you must serve at least two years of service at an NHSC-approved Health Profession Shortage Area site. It is the applicant's responsibility to assess the criteria for application and contact HRSA with eligible questions. This Fellowship does not prevent participation. It is important to point out that **this fellowship is a one-year program** and we cannot guarantee that you would be hired after the Fellowship year. If you were not hired after the Fellowship year, you would have to find employment at another Health Profession Shortage site. If you are unable to make arrangements directly with the HRSA program you may be liable to pay back funds.
