And the impact of this team-based approach is evident in our patients' high quality health outcomes.

In the pages of this report, we're excited take you behind the scenes at our health centers to show how Erie teams collaborate to positively impact our patients' health. 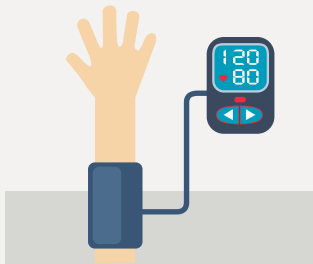
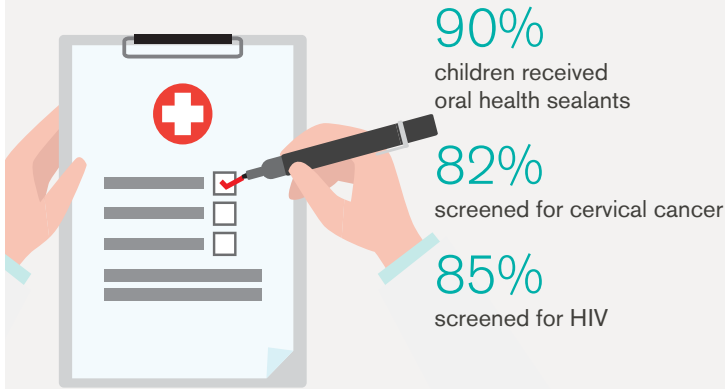

SANKOFA VILLAGE WELLNESS CENTER UPDATE

A community-led vision for health and wellness in West Garfield Park


Last year, Erie announced our plans to open a new health center within the Sankofa Village Wellness Center.

Scheduled to open in 2025 at the corner of Madison and Kildare in Chicago’s West Garfield Park neighborhood, the Wellness Center will be a 60,000 square foot building housing a collective of organizations serving people of all ages with affordable, high-quality physical and mental health and wellness services. Erie joins the YMCA of Metropolitan Chicago, Rush University Medical Center and West Side United as an anchor tenant in the Wellness Center where we will provide holistic medical, dental and behavioral healthcare, eventually serving more than 6,000 patients a year.

As architects and construction teams finalize plans, Erie has been active in the neighborhood, participating in town halls, festivals and other gatherings to deepen our understanding of the needs of the community (as shown above). The Wellness Center is a core part of the Sankofa Wellness Village—a community-led vision for neighborhood revitalization born of the need to address and reduce the health disparities that have affected people in West Garfield Park for decades. As we prepare to break ground, Erie continues to build a robust plan to engage the community through educational programming.



Outreach to patients at the right time, in the right way

Preventative health is an integral part of primary care.

To promote health by catching problems early, Erie doubled down on and streamlined our outreach efforts to patients to encourage them to stay up to date with important screenings, vaccinations and wellness exams. A centralized team is now leveraging data and new outreach tools to collaborate on strategies to ensure Erie is targeting the right patients, at the right time, in the most impactful ways. Patients due for services like colorectal cancer screening, flu shots and well-child exams receive alerts in MyChart, our new patient portal; text messages; and personal phone calls to notify them what action to take and offer assistance with scheduling.

To help ensure patients don’t lose access to insurance, Erie also launched a major educational outreach effort to educate and support our 64,000 patients with Medicaid through the complicated annual process of re-applying for benefits that had been paused during the pandemic.

Extending Erie’s compassionate care to new arrivals

For more than 66 years, Erie has been caring for patients who have difficulty accessing healthcare due to financial, language and other social barriers.

IT’S WHAT WE DO: care for people regardless of their insurance status, immigration status or the ability to pay.

We are also partnering with local community organizations to distribute information about Erie to migrants living in shelters and streamlining the intake process for people in need of care. Because of our particular expertise in reproductive and pediatric care, we are serving many patients at various points in their prenatal journey, as well as helping kids meet the health requirements needed to register for school and have a healthy start to their education in Chicago.

So when the buses carrying migrants started arriving from the southern border of the United States in August 2022, we stepped up as one of the first healthcare providers to offer needed support, and we continue to do so for more than 1,000 of the 35,000 additional migrants who have arrived since. In July 2023, Erie began partnering with the City of Chicago and Chicago Public Schools at the Welcome Center at Clemente High School, where we are able to connect families with ongoing services within our health centers.



Getting patients the right level of care they need in the moment

Erie’s commitment to improving access to care includes our goal to help patients get the right kind of care, right when they need it.

To better support patients in this way, Erie implemented a nurse triage program. Previously, when a sick patient called Erie, a message was routed to an Erie nurse working onsite. However, there might have been a delay in that busy nurse’s ability to call the patient back, which sometimes resulted in a delay in care. Now, when someone calls Erie’s patient access center, they can speak directly to one of 15 Erie nurses who answer live calls. The triage nurses assess the patient’s symptoms and decide what level of care the patient needs. Do their symptoms require a provider see them in-person in a health center? Or would a telehealth appointment work, and be more convenient? If deemed appropriate, nurses also can guide a patient through managing symptoms at home, saving the patient the need to make an appointment.

Health is a team effort

We all have health goals. We might want to deliver a healthy baby, lower blood pressure, prevent diabetes, or overcome a dependency on substances. And we are all more successful when we are surrounded and uplifted by a team that can help us live our healthiest lives. At Erie, our patients benefit from strong, compassionate, interdisciplinary teams, located under one roof, that support our patients' goals, work to reduce obstacles they face along the way, and empower them to be at the center of their own team.

Erie and families collaborate to establish a strong foundation for lifelong health

All children deserve the healthiest possible start to life and ongoing support to nurture them as they grow. At Erie we view our holistic, team-based pediatric program as the front door to establishing a lifelong foundation of health and wellness.

Forty-three percent of Erie patients are under the age of 18. We are a national leader in ensuring pregnant patients get early access to prenatal care, setting the stage for a lifetime of health and wellness for our youngest patients. We deliver more babies than any other community health center in Illinois and more than 99% of health centers nationally. Our pediatric providers visit newborns while they are still in the hospital to meet the family and ensure that they establish care at Erie right from the start. And a team is there to provide wraparound support to parents as they navigate the challenges of raising children at every stage.

Erie provides Supplemental Nutrition through Women, Infants and Children (WIC) services including healthy food, nutrition education, cooking classes, and breastfeeding promotion. Our social drivers of health team links parents to resources like diapers, safe sleeping equipment and car seats. As children grow, we provide developmental screenings and interventions, immunizations, and oral health care. We can link parents and kids—including new mothers experiencing post-partum depression and children and teens dealing with anxiety and other concerns—to onsite, integrated behavioral health support. As children grow into teens, the Erie Teen Center strives to empower young people to become the center of their healthcare team and take control of their own healthcare journey.

An Erie patient's team extends beyond the exam room

Social, environmental and behavioral factors outside of the exam room — referred to as the social drivers of health — have just as much impact on health as the clinical care a patient receives.

To promote a person's chances to successfully achieve their health and lifestyle goals, many Erie patients and their primary care providers team with a variety of staff who specialize in providing health education, navigation and resource support. We meet patients where they are, and match the level of support to their specific needs.

All Erie patients have access to one-time, in-the-moment support from Erie's social drivers of health (SDOH) team. Should a patient tell their provider that there's something standing in the way of their health goals, an SDOH team member can connect them with resources such as transportation assistance, linkage to affordable housing programs, or nutritious food.

Health promoters are specifically trained to assess patients' understanding of their conditions and their health literacy, and provide tailored educational support that complements the work of other care

team members. For example, a patient with diabetes might partner with a nurse to train them how to use their glucometer, a behavioral health therapist to address stress caused by managing their condition, and one of Erie's education programs like the "Manage My Diabetes" group and 1:1 class series. Patients working to manage chronic illnesses partner with a care or case manager for ongoing, individualized outreach and support.

Patients and their care teams are leveraging data to guide treatment options

Supported by our 2022 transition to a state-of-the-art electronic health record system (Epic), Erie has bolstered our efforts to collect and analyze data to support our patients' health goals.

Compassionate care providers are now better equipped with strong data that guides comprehensive treatment options to help patients live their healthiest lives. Erie patient Gregory Rau has worked to control his hypertension through portion control and exercise. But he's also enrolled in a new program that gathers blood pressure data from patients and sends them educational hypertension self-management materials and reminders via a phone app.

Erie provided Gregory with an at-home blood pressure monitor. His test results are sent to Erie's new patient portal, MyChart. His primary care provider, Dr. Joan Savage, can then monitor his values to confirm whether his medication is working or reach out to Gregory to adjust his regimen. The ease of this digital tool has resulted in a significant increase of patient self-reported data. The system allows Erie to calculate a patient's average blood pressure outside of the exam room setting to really see the impact of the medications and lifestyle choices patients are making. Providers can avoid under- or over-dosing a patient with blood pressure medications, and provide comprehensive and individualized advice.

Gregory (at right) credits this teamwork with his health:

Erie teams helped increase the number of patients managing their blood pressure by nearly 20 percentage points over the past three years.

Patients overcoming substance use disorders have access to a collaborative support team

People with substance use disorders (SUDs) often face a vicious cycle where—in social and economic inequities both compound their medical and mental health needs and impede their access to treatment.

Erie takes a team-based approach to breaking this cycle and improving health outcomes with its Medication Assisted Treatment (MAT) program. Launched in 2018 and expanded last year, Erie's MAT program provides interdisciplinary, comprehensive, long-term services for patients looking to recover from SUDs—all regardless of insurance status, and all under one roof.

While substance use treatment has historically been siloed from primary care, patients enrolled in Erie's program don't have the challenge of needing to visit a patchwork of different facilities—instead the Erie team supporting them are all communicating and collaborating. A patient's primary care provider (PCP) can link a patient directly to a behavioral health therapist, who does an assessment and can enroll them in Erie's MAT program. An Erie psychiatrist collaborates with the patient's PCP on medication administration. The patient participates in regular individual or group therapy sessions—expanding their team by fostering peer support networks—and is further supported by a care coordinator who

ensures that they are going to appointments. Erie's social drivers of health team members can connect the patient with resources to help access affordable medications, transportation, safe housing and many other social factors that support them in their recovery journey. And as Erie's MAT program rolls out training for Erie's entire staff on medications like naloxone to reverse opioid overdoses and buprenorphine to treat opioid dependence, an Erie patient's team will grow even larger.



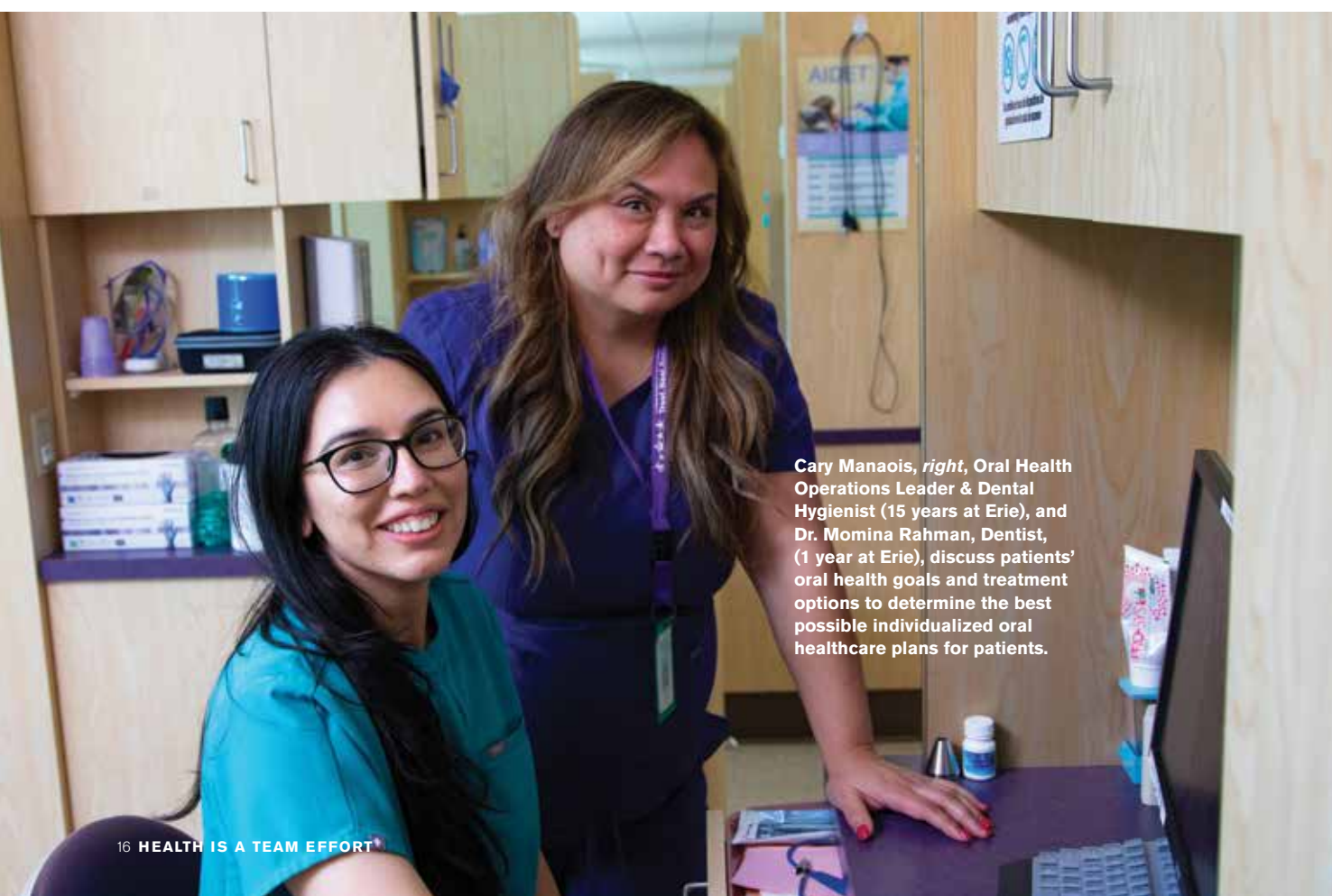

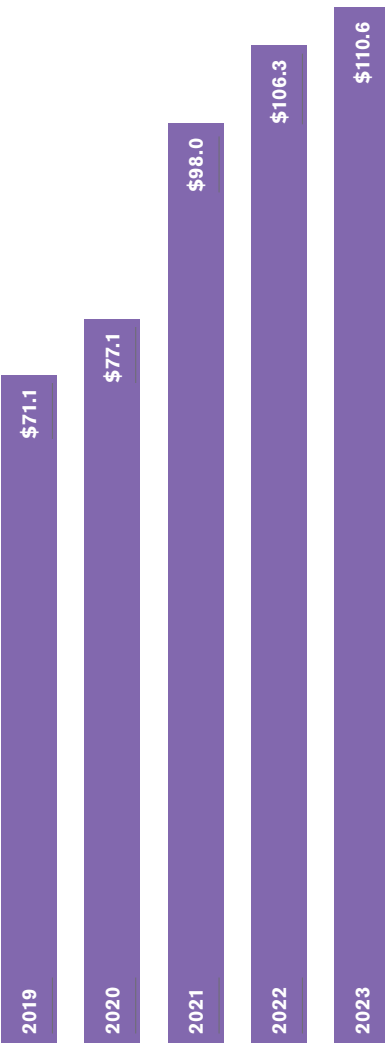

REVENUES (at year end, dollars in millions)

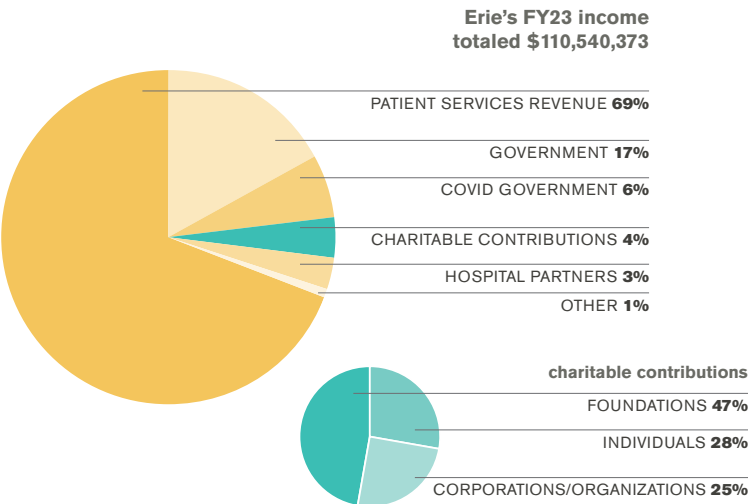


Starting in FY21, revenue growth reflects a significant infusion of government grants and fees in response to the COVID-19 pandemic.

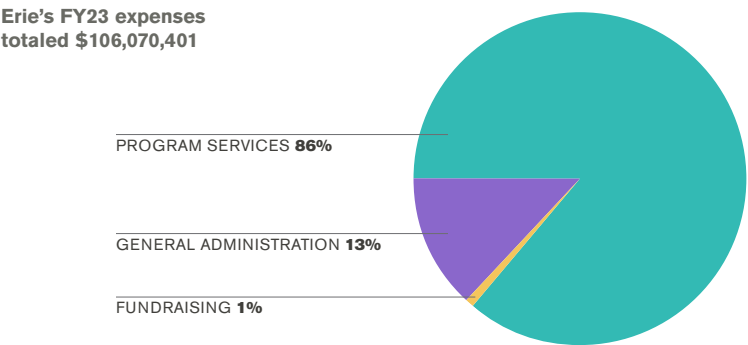
FY23 TOTAL REVENUE SOURCES

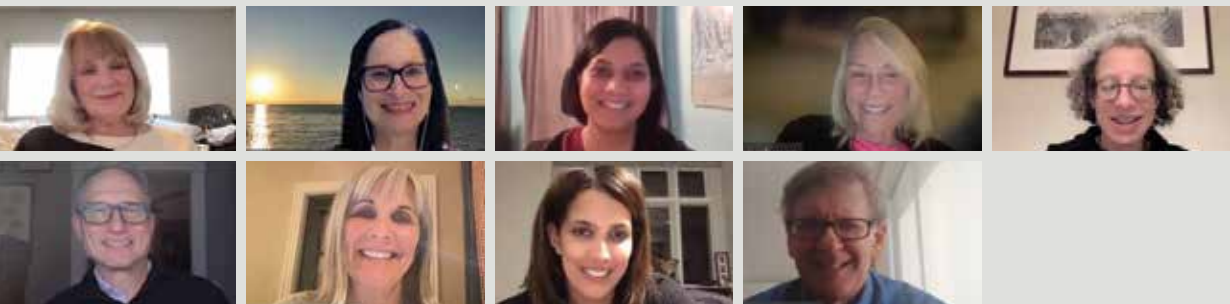
